Privacy Policy

This Policy applies between you, the User of this Website and Your IVF abroad Ltd, the owner and provider of this Website. Your IVF abroad Ltd takes the privacy of your information very seriously. Definitions and interpretation

1. In this privacy policy, the following definitions are used:

 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d.
 - "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Your IVF abroad Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

How and Where Do We Store Your Data

Data retention

Your rights
